

PRIVACY POLICY

Epic Spirit Ventures, Inc. (the “Company”) respects the privacy of all visitors to www.theepicbrands.com (the “Site”). Except as otherwise provided in this Privacy Policy, the information collected through the Site is not shared with third parties.

Children's Privacy

We do not knowingly collect personally identifiable information from children under the age of 13 on our website. If you become aware that your child under the age of 13 has provided us with personal information, please contact us at the email, phone number, or address provided in the Company’s Terms of Use posted at www.theepicbrands.com. If we become aware that a child under 13 has provided us with personal information, we will take steps to remove such information and terminate the account.

Cookies

The Company utilizes passive tracking mechanisms in the form of “cookies.” A cookie is a small text file that a website or e-mail may save to your internet browser and store on your computer's hard drive for use in subsequent visits to the Site or other websites. One type of cookie, a “session cookie,” may be used but it remains active only for as long as the visitor is using the Site during a given session. More permanent cookies are used for activating an account with the Company through the Site, which cookies are placed and stored as a small data on the hard drive of the computer of the person using the Site (each a “User”). Cookies are accessible only by the Company and its authorized agents and contractors. Cookies can contain pieces of information that make the Site easier or more enjoyable to use. The Company uses a session cookie to maintain a single login session. A User may block or disable one or more cookies during a given session, but certain webpages of the Site may not fully function during the session as a result.

Information we collect

The Company may collect any personally identifiable information (such as first and last name, credit card number, home address, e-mail address and telephone number) that you provide when you interact with the Company in certain ways such as when you:

- Make a purchase;
- Create or edit your registration or wish list;
- Participate in a contest, sweepstakes or other promotion;
- Fill out a survey or questionnaire;
- Engage with the Company through third-party social networking sites; or
- Contact a Company customer service representative.

In addition, each time you visit the Site, the web server may automatically collect certain types of information when you interact with the Site, e-mails and online advertising. Some examples of automatic information we may collect are as follows:

- We may record your internet service provider's address, your internet protocol or IP address, the web page from which you came, your web browser software, and the type of handheld or mobile device used to link to the web page;
- We may collect a record of your activity or your “clickstream” while visiting the Site or our affiliates’ websites;
- We may use “cookies” (see above section explaining what cookies are) to recognize when you are shopping on the Site; and
- We may use web beacons or similar technologies which allow us to know if a particular web page was visited, an e-mail opened, or if the advertisements on the Site or other sites were effective.

Uses of Information

Information collected from a User through the Site (“User Information”) may be used by the Company to identify a User for purposes of selling product to the User through the Site, to communicate with a User with regard to an order placed by the User through the Site, to send advertisements, and when the Company is legally compelled to do so or when it feels it is necessary to do so in order to protect the Company’s business interests.

Amendments to this Privacy Policy

This Privacy Policy may be updated and revised from time to time. If we change this Privacy Policy we will post the updated policy at this website. You can tell if it has changed by checking the revision date that appears at the end of this Privacy Policy. You agree that the information that we gather now will be subject to the Privacy Policy in effect at the time of use. All Users should check the Site periodically for updates.

Disclosure of Information

User Information is available to the administrative and management personnel or agents of the Company on an as-needed basis only. User Information may be shared with one or more affiliates of the Company for purposes of advertising the affiliate’s products or services. In addition, the Company provides information to other companies that provide support services that help us bring you the products and services we offer, market our products and services, or process your transactions. The Company reserves the right to make any and all disclosures of User Information as necessary or appropriate to comply with applicable law, regulation, or legal proceeding, and will disclose User’s Information to the extent necessary to defend itself against any claims from User or third parties.

Notice to California Residents - Your California Privacy Rights

Under California law, a California resident with whom the Company has an established relationship has the right to request certain information with respect to the types of personal information the Company has shared with third parties for their direct marketing purposes, and the identities of those third parties, within the immediately preceding calendar year, subject to certain exceptions. Maryland Personal Information Protection Act (“MPIPA”)

The Company complies with MPIPA with respect to all User Information obtained regarding an individual’s name and payment information (“MPIPA User Information”) including (a) taking reasonable steps to protect against unauthorized access, use, modification or disclosure of the personal information it collects, and (b) implementing and maintaining appropriate security procedures and practices. MPIPA User Information is not used for any purpose by the Company and its affiliates other than to process requests and orders, to serve customers when they have questions or problems, to perform normal business operations, such as billing, collection and accounting, and otherwise only in compliance with applicable law.

Security

The Company uses security technologies and procedures to help protect personal User Information from unauthorized access, use, or disclosure. The Company transmits User Information via SSL Certificate, firewalls and on computer systems with limited access, which are located in controlled facilities. We protect information we store which we deem to be highly confidential information through the use of encryption.

Linked Sites

The Site may contain links to a variety of providers who offer content, services and e-commerce. Many of these links may be in 'frames,' meaning that the Site will still be visible as you move throughout the linked site(s). Please be aware that when viewing linked sites you are no longer under the Company Privacy Policy, and you should review the linked site’s privacy policy before divulging any personal information, including your e-mail address, credit card number (for an e-commerce link), name, etc.

User's Responsibilities

The Company uses commercially reasonable efforts to protect User Information, but the Company does not guaranty that any User Information shall remain confidential or safe from unauthorized access, use, or disclosure. Neither the Company nor any of its affiliates, their respective owners, stockholders, members, managers, directors, officers, employees, agents and other representatives, and their heirs, personal representatives, successors and assigns affiliates, agents, or contractors will be liable for the disclosure of any User information due to User negligence, errors in transmission, or unauthorized acts of third parties, except as otherwise provided by applicable law.
